- Platform Supply Vessels (PSV) – to support high-capacity supply ships, either in-deck or cargo-hold.
- Anchor Handling Tugs Supply (AHTS) – to provide anchorage and towing for floating oil platforms (i.e. jack-ups and semi-submersible vessels)
- Multi-Purpose Supply Vessels (MPSV) – to provide universal support for a variety of maintenance with high-capacity equipment like cranes, ROV and wellheads etc.
- Fast Supply Intervention Vessels (FSIV) - to provide swift/urgent delivery of shipment
- Crew Vessel – to offer high-speed and cross-site shuttle services to transport platform workers
- Stand-by/Rescue vessels – to offer security and patrol services for intervention against evacuation and fire-fighting needs
